

RECEPTION FEES FOR SMALL AMOUNTS OF WASTE FROM 1.1.2022

The fees apply to small quantity waste loads that are brought by passenger car, trailer or van. Waste loads delivered by a truck, are considered as large waste loads. In these cases a pricelist for large amounts of waste applies.

Prices include VAT 24 %. The fees are based on the waste tariff approved by the waste treatment committee.

1) Bio waste is not received at the Korpo, Houtskär or Mörttilä sorting stations.

2) Larger amounts of tree stumps are priced according to the pricelist for large amounts of waste. Large amounts of tree stumps are received only at the Korvenmäki and the Topinoja waste treatment centres.

3) Received only at the Korvenmäki and the Topinoja waste treatment centres.

4) Loads larger than 1 m³ are received only at the Korvenmäki and the Topinoja waste treatment centres.

5) Asbestos loads larger than 200 l are priced according to the pricelist for large amounts of waste. Large amounts of asbestos are received only at the Korvenmäki waste treatment centre.

6) Pressure treated wood loads larger than 1 m³ are priced according to the pricelist for large amounts of waste. Loads larger than 1 m³ are received only at the Korvenmäki and the Topinoja waste treatment centres. Railway sleepers, telephone and utility poles and their pieces are not classified as municipal waste from households. They are priced according to the pricelist for large amounts of waste.

7) The limit for reception for fluorescent tubes is 30 pcs or 50 kg. Large amounts are received only against prior notice at the Topinoja waste treatment centre.

Please note

- Waste shall be sorted in to the waste containers in the waste treatment centres and sorting station according to instructions.

- The minimum fee for all waste is 1,00 €/unit, except for fryer grease with the minimum fee of 0,25 €/l.

- Accepted forms of payment are cash, debit cards, Visa Electron, Visa and MasterCard. Please note, that e.g. American Express is not a valid means of payment.
